Law enforcement. Embarq Health, LLC. may release PHI if asked to do so by a law enforcement official:

Concerning a death, we believe has resulted from criminal conduct,

Regarding criminal conduct at our offices,

In response to a warrant, summons, court order, subpoena or similar legal process,

Serious threats to health or safety.
